# Frequently asked questions.

## What makes Lanyon Bowdler different to other personal injury solicitors?

As solicitors who specialise in brain injury, catastrophic injuries, spinal and amputation cases, we have experience in signposting our clients to independent and experienced case managers who will help establish care regimes, suggest therapies and source appropriate accommodation. With this multi-disciplinary, holistic approach we are able to offer maximum support to the injured person and their family at a time of crisis. With the right therapies and services, the correct care package and support, those who have become carers can step back and return to their role of partner, mother or father rather than carer, enabling them to regain quality time with their loved one. ## What do I need to prove to be successful in a personal injury claim?

To be successful in a straightforward claim, you need to prove two things:

- That the accident was caused by someone else's negligence or a breach of statutory duty.
- That the negligence/breach caused you physical or mental injury.

## What are my chances of winning my case?

We will make an initial assessment on the merits of your case when we first meet with you and will continue to review the merits of your case as it progresses. The first meeting with you is held free of charge and will take as long as is necessary for us to understand your circumstances. Our assessment will be based upon your own evidence, our research and the significant experience we have in personal injury cases. We assess the prospects of success throughout the conduct of the case and if at any stage we receive evidence that alters our view of the prospects, we shall advise you immediately.

## How long will my claim take?

This will depend upon the complexity of your case. We will give you an estimated timescale once we have more information. The main factors which will impact upon the length of the claim are the attitude of the defendant towards settlement, the depth of investigations and your medical prognosis. We shall minimise the time taken to settle your claim by setting out your claim to the defendants clearly and robustly.

## How will I pay for your services?

A number of funding options are available to suit your budget and needs. These include “no win no fee” agreements, before the event legal expense insurance and hourly rates. We will detail your funding choices and the pros and cons of each when we meet, and we will not proceed without your approval of your funding strategy. These are discussed thoroughly with you in your initial meeting, which is free of charge.

## How will I avoid a large bill that I was not expecting at the end of the case?

# Example claims.

## Claim A

H was a front-seat passenger in a car which was in a high speed collision on the M5. She sustained a fractured sternum, whiplash to the cervical spine, a ligament injury to her shoulder and a psychological injury. These injuries resulted in a serious disability and impacted on her ability to work and on her daily needs.

The driver of the car had legal expenses insurance and their panel firm was initially instructed. H was not offered a face-to-face meeting at any time, and was advised that £16,000 was a good settlement figure. She rejected this, and decided to instruct Lanyon Bowdler who were local to her and had the necessary knowledge and experience. With our expertise, she recovered £400,000 in settlement.

## Claim B

A was a driver involved in a road traffic accident in July 2018, when another vehicle was overtaking on a bend. The Claimant sustained multiple injuries including a traumatic brain injury, serious chest injuries, and pelvic fractures. Frontal lobe damage resulted in dysexecutive syndrome and associated behavioural changes. The claim was brought against the other driver and their insurer.

Liability remained contested throughout the claim, with the defendant alleging the claimant lost control of their vehicle ahead of collision. Parties entered into rigorous negotiations at a joint settlement meeting. A settlement sum of £2,900,000 was agreed, accounting for a percentage discount in respect of liability, which the Court approved.

Injury through someone else's negligence can happen, and the consequences can be life-changing. Livelihoods can be lost and care needed.
